



End User License Agreement (EULA)

Please read this document as it contains important information on the legal terms and conditions governing the use of the Software products and integrated Software and Hardware products (collectively, "PRODUCTS").

This EULA constitutes a legally enforceable agreement between the purchaser (the "Licensee" or "you"), and Satmap Systems Ltd (SSL) and Satmap Systems Inc. It applies to all PRODUCTS supplied by SSL, either pre-installed or supplied subsequently in the form of updates, upgrades, modifications, bug fixes or new products, as supplied on various Software delivery media, including but not limited to, the internet, SD Cards ("map cards"), CD-ROMs, DVDs or any other form of data delivery. SSL is willing to license the PRODUCTS, and any other information or material relating to the PRODUCTS provided by SSL to you, ONLY IF YOU ACCEPT ALL OF THE TERMS IN THIS EULA. SSL is not willing to make the PRODUCTS available under any other terms or subject to any other conditions.

License Acceptance: Once you use the device, or break the seal on the Software, or download any data, you will be deemed to have accepted the terms of this EULA, and will be bound by them. BEFORE YOU USE THE DEVICE, OR BREAK THE SEAL ON THE SOFTWARE, OR DOWNLOAD ANY DATA, CAREFULLY READ THE TERMS AND CONDITIONS OF THIS EULA. BY USING THE DEVICE, OR BREAKING THE SEAL ON THE SOFTWARE, OR DOWNLOADING ANY DATA, YOU ARE REPRESENTING THAT YOU HAVE THE CAPACITY AND AUTHORITY TO BIND YOURSELF TO THE TERMS OF THIS EULA AND ARE CONSENTING TO BE BOUND BY THIS EULA. IF YOU DO NOT WISH TO BE BOUND BY THE TERMS OF THE EULA, YOU MUST NOT USE THE HARDWARE OR ANY OF THE DATA SUPPLIED BY SSL OR BREAK ANY PRODUCT SEALS. YOU MUST IMMEDIATELY RETURN ALL THE PRODUCTS TO THE POINT OF PURCHASE, ALONG WITH THE PROOF OF PURCHASE, WHEREUPON A REFUND WILL BE GRANTED. Non-transferable License: The licenses granted in this EULA to use the PRODUCTS of SSL and its suppliers and licensors are personal to the Licensee, and the Licensee agrees not to transfer (by operation of law or otherwise), sublicense, lease, rent or assign its rights under this EULA, and any such attempt shall be null and void. SSL may assign, transfer or sublicense this EULA or any rights or obligations hereunder at any time in its sole discretion.

User License: Subject to the terms and conditions of this EULA, SSL hereby grants the Licensee a limited, personal, non-commercial, non-exclusive, non-sublicensable, non-transferable license to download and install, on only ONE (1) piece of Hardware, ONE (1) copy of the Software.

The license granted to the Licensee is made expressly subject to the following limitations: the Licensee may not itself (and shall not permit any third party to): (a) copy, other than as expressly permitted, all or any portion of the Software, except that the Licensee may make ONE (1) copy of the Software for archival purposes for use by the Licensee only in the event that the Software shall become inoperative; (b) modify or translate the Software; (c) reverse engineer, decompile or disassemble the Software, in whole or in part; (d) create derivative works based on the Software; (e) publicly display the Software; (f) rent, lease, sublicense, sell, market, distribute, assign, transfer or otherwise permit access to the Software to any third party; or (g) exercise any right to the Software not expressly granted in this EULA.

Third Party Products: The Software can only be used on Hardware supplied by SSL; it cannot and must not be used on hardware supplied by any other manufacturer. The Hardware can only use other Hardware products and software supplied by SSL; it cannot and must not be used with products from any other supplier. Efforts to use the Hardware or Software with third party products constitute a material breach of this EULA and will render any Warranty void immediately and outstanding.

Software Upgrades and Updates: SSL reserves the right to discontinue, update, upgrade, fix and/or modify the services and products supplied to the Licensee or made available to the Licensee through the use of the PRODUCTS, with or without notice. This EULA does not grant the user any rights to Software upgrades, updates, modifications or bug fixes. You are only permitted to use this IPR in accordance with the terms and conditions of this EULA. All rights not specifically granted in this EULA are reserved by SSL. The Licensee hereby agrees to abide by all applicable copyright and other laws and by all applicable international treaties.

Restrictions: All PRODUCTS supplied by SSL are protected in full by copyrights, trademarks and patents owned by SSL and/or its suppliers and by applicable law and treaties. You or any other persons or organization(s) are not permitted to modify the PRODUCTS under any circumstances. The Licensee may disclose Confidential Information if required by statute, regulation, or order of a court of competent jurisdiction, provided that the Licensee provides SSL with prior notice, discloses only the minimum Confidential Information required to be disclosed, and cooperates with SSL in taking appropriate protective measures.

Satmap Limited Warranty

If the Hardware is repaired by or on behalf of SSL as part of its warranty obligation, the Warranty Period shall expire on the later of (a) the date on which the original Warranty Period is set to expire and (b) the date that is six (6) months from the date of the repair, at a cost to you determined by SSL.

Exclusions from this Warranty: This Warranty only applies to Hardware products. For information (including Warranty information) on all Software products, including pre-installed Software, please refer to supporting documents, including the EULA.
